HOUSE RULES FOR MEMBERS AND RENTERS

1. Club members and children residing in their home under age 21 are entitled to all Clubhouse.
2. All guests and members of recognized yacht clubs must be accompanied by a member when upon Club.
3. Members will be required to register the names of their guest in the Club register.
4. All members and guests must wear identification.
5. Members entertaining guests or visitors shall be held responsible for their guests observance of Club.
6. Crewmembers of boats owned and sailed by members of the Club and participating in sailing events shall enjoy the privileges of the Club while accompanied by the boat.
7. Members and guests shall conduct themselves with proper respect and shall not engage in boisterous or offensive behavior. Anyone guilty of a breach of the foregoing rules of conduct shall be requested to leave the premises by an officer of the Club or the bar duty member.
8. Any member or guest who willfully or negligently defaces, injures, or destroys either the property or equipment of the Club shall be held liable for the full face value thereof.
9. No one is permitted to rent, borrow or remove any piece of equipment belonging to the Club without permission of the Port Captain or Flag Officer.
10. The Club will not be responsible for the loss or damage to any property of the members or guests.
11. The Club Rental Committee has full charge of the Club quarters subject to the authority of the Board of Directors.
12. Nothing shall be posted on the bulletin board or walls without permission of the Board of Directors.
13. Children under 18 years of age shall be accompanied/supervised by an adult Club member while on Club premises.
14. All regulations which apply to adults shall be obeyed equally by all Members and guests.

- 15.** No dogs (except seeing eye dogs), or other pets are allowed inside the Clubhouse. Club members and guests shall be responsible for their pets at all times when on Club premises.
- 16.** A \$100.00 advance refundable compliance deposit will be required for each group utilizing the Clubhouse for a function. Deposit will be forfeited if Club is not left in the condition as rented or for violation of House Rules.
- 17.** Members and guests are held responsible for insuring that their family and guests under 21 years of age remain clear of the bar area. NO persons under the age of 21 are permitted to sit at the bar.
- 18.** Non-members are not allowed behind the bar or allowed to serve alcoholic beverages at any time. (Outside bar tenders hired by the Club are an exception).
- 19.** Each Club member is allowed to use the Club dock 12 nights per, year and an unlimited number of days, except in the case of Club-sponsored events or an emergency. Day use ends at 9:00 P.M. Prior permission must be obtained from the Port Captain or a Flag Officer.
- 20.** Violation of any of these regulations may result in a fine, suspension, or expulsion by the Board of Directors, as provided in the By-Laws of the Club.
- 21.** The Club Rental Policy Club Rental Program, Rental Agreement, and the House rules comprise a complete description of the rules and regulations governing the rental of the Spinnaker Yacht Club facilities.
